

Milestone 使用者授權合約

此為原始 Milestone 使用者授權合約的翻譯版本。倘若出現與本使用者授權合約的條款與條件解釋相關的不確定性與爭議，原始英文版本的效力將優先於本翻譯版本。Milestone 使用者授權合約的原始英文版本位於此當地語系化版本之後。

注意：若您是 Milestone 經銷商、系統整合業者，或代表第三方安裝本「產品」，應確認您代表的一方接受本「終端使用者授權合約」並表示已同意自願提供個人資料予 Milestone Systems 以進行註冊。

本使用者授權合約（以下簡稱「EULA」）為您（個人或單一法人）與 Milestone Systems A/S（以下簡稱「Milestone」）之間針對 Milestone 產品或公用程式的具有法律拘束力之協議，其中可能包括相關之軟硬體元件、媒體、書面資料、線上或電子檔以及任何更新或更正（以下簡稱「產品」）。若本「產品」是您向 Milestone 購買的電腦或伺服器系統之一部分，則這類系統中用於本 EULA 提及目的的所有軟硬體元件，都必須被視為「產品」的一部分，但受到系統文件中個別第三方授權合約規範的第三方軟硬體元件，以及以其他方式合併於系統者除外。

當您安裝、部署、複製或以其他方式使用「產品」，即表示您同意受到本 EULA 條款之拘束。如果您不同意本 EULA 之條款，請勿安裝或使用「產品」。您可以在購買「產品」後的 30 天內將產品連同所有相關資料退回購買地點，並獲得扣除運費與手續費的全額退款。若您或您的代表，包括 Milestone 經銷商（代表您）在您購買「產品」時或之前已接受此 EULA，則不適用此退貨政策。此外，此退貨政策不適用於 Milestone Husky 產品與相關硬體。「產品」受到著作權法及國際著作權公約，以及其他智慧財產權法律及條約之保護。請注意，「產品」的所有軟體部分是授權給您，並非出售給您。對「產品」之授權，不構成智慧財產權之租賃或銷售情事，亦不構成「產品」中任何智慧財產權所有權之移轉。

對於需要軟體授權碼（SLC）的 Milestone 產品，您所獲得的授權，係透過您購買「產品」時所獲得之軟體授權碼作識別。

附屬公司。 您根據本 Milestone XProtect Corporate、Milestone XProtect Expert 和/或 Milestone XProtect Professional+ 的 EULA 而獲得的授權，讓您能夠向您的附屬公司及其各自員工、代表和其他為您的附屬公司工作之人授予此類產品的存取權限，並允許他們使用此類產品，前提是您將始終全權負責附屬公司根據此 EULA 的條款而訪問和使用產品。這項權利也涵蓋您為 Milestone XProtect Corporate、Milestone XProtect Expert 和/或 Milestone XProtect Professional+ 而購買的 Milestone XProtect Extensions 與元件。您應確保 (i) 您的每家附屬公司在被授予「產品」存取權限之前都提交本 EULA，並且 (ii) 您的附屬公司均遵守本 EULA 的條款。本 EULA 所稱之「附屬公司」，包含任何直接或間接由您控制，或控制您，或跟您處於共同控制之任何法人個體，其中「控制」應指擁有超過 50% 的投票股權（有權選舉或任命絕大部分董事會成員），或類似的管理權限。

接受自動遠端更新。 您組織的系統管理員可於現在或日後，使用工具或作業系統方法，在您電腦上啟用軟體產品的遠端與自動更新或安裝；這類工具的範例如 Milestone Software Manager。若使用這類工具進行自動「產品」更新，可能不會提示您接受新「產品」的 EULA。當您接受目前本 EULA，即表示您已指派您的系統管理員代表您接受未來產品更新後之 EULA。

AWS 雲端部署。 Milestone XProtect 視訊管理軟體產品亦透過自備授權（以下簡稱「BYOL」）或包括在內之 Milestone XProtect® Essential+ 授權，以 Amazon Machine Image（以下簡稱「AMI」）方式作交付，並且可以透過利用相關 CloudFormation 指令檔，部署在 AWS 雲端服務基礎建設上。此指令檔在您 AWS 帳戶內的新虛擬私有雲端（以下簡稱「VPC」）執行預設的「產品」部署。在您特定 AWS 雲端服務基礎建設中部署「產品」所必要範圍內，您可以修改 CloudFormation 指令檔或其所產生之預設部署。此 CloudFormation 指令檔係以「現狀」提供，無任何種類之保證，包括但不限於符合特定目的之默示保證。如對 CloudFormation 或其所產生之預設部署為修改

者·Milestone 茲明確表示，對該等修改情形不為任何保證，亦不承擔任何責任。基於部署作業以及對部署「產品」之使用情形所生之完整風險及責任，應由您（即使用者）自行承擔。

智慧財產權。「產品」及其任何副本內含之全部所有權及權利（包括但不限於著作權）為 Milestone 所有，或者在第三方參與該「產品」的情況下，僅該參與部分的所有權及權利為我們的授權人所有。Milestone 保留所有未表明授予之權利。

產品可能包含根據 HEVC Advance 專利組合授權而獲授權的 HEVC/H.265 技術，而且該技術之使用情形係屬於 patentlist.hevcadvance.com 上列出之一項或多項申請專利範圍。

侵犯第三方權利。Milestone 應確保「產品」不侵犯任何第三方智慧財產權，但關於專利方面，唯有符合下列兩條件者成立：(a) 在您購買時，該專利已於美國或歐盟境內授予並公佈，以及 (b) 唯有「產品」在未搭配其他產品或技術使用時，以獨立狀態侵犯專利權。若您遇到對您發生的任何動作被指控有此侵權行為，應立即以書面通知 Milestone。Milestone 應承擔此案件的唯一行為，以及案件附帶的訴訟費用。Milestone 應指派具有決定權的律師，代表進行訴訟，或與您（使用者）進行協商。Milestone 有權就單方考量，取得您繼續使用「產品」的權利，或以其他具有相似功能的產品修改或替換「產品」以結束此侵權事件；若以上兩者皆無法讓 Milestone 以合理成本達成，則此 EULA 終止且立即生效。一旦發生終止事件，您對 Milestone 將不再有進一步求償之權，包括但不限於補償或賠償的權利。

錯誤修正。「產品」中的缺陷或錯誤，僅在影響「產品」整體功能，或妨礙「產品」運作時，才能視為重要。若您在購買產品的 90 (九十) 天內，書面指出「產品」具有重要缺陷或錯誤，Milestone 有責就單方考量，(i) 遞送一份無重要缺陷或錯誤的新「產品」，(ii) 免費補救或修正缺陷或錯誤，或 (iii) 終止本 EULA 並在您退回「產品」所有副本時退還授權費用。本段落的條款構成您對「產品」缺陷或錯誤之唯一補償。

不含保證。除非 Milestone 提供特定保證作為您「產品」文件的一部分，Milestone 明確聲明未對「產品」提供任何保證。「產品」及任何相關文件均「按現況」提供，不含任何明示或默示之保證，包括但不限於對適銷性或符合特定用途之默示保證。使用者須自行承擔使用或執行「產品」之全部風險。請注意，「產品」搭配特定設備或其他軟體使用時，可能造成您執行可能受到相關法律限制或違法之監視動作及資料處理，包括（但不限於）資料隱私權與刑法。使用者須自行承擔使用上之適法性的全部責任。

禁止使用。「產品」之採用與使用情形，均必須遵守使用所在司法轄區、國家或地區的適用法律。這包括但不限於使用產品監控及記錄的可能法律限制、在「產品」中儲存記錄資料與其他資料的政策，以及從「產品」匯出記錄的資料時處理資料的方式。您須自行熟悉並遵循此類法律及限制。對於違反此類法律及/或限制所導致的任何直接性、間接性或必然性損失或損害，Milestone 概不負責。

資料隱私與保護。 您聲明並確認您知道本「產品」收集並處理透過任何視訊來源，包括攝影機、DVR、NVR 或以任何其他方式提供的個人資料，且 Milestone 及其授權人不承擔與收集以及處理此類個人資料作為本「產品」輸入或使用產品的方式、其品質或充分性的責任或義務，也不得獨立存取任何此類所收集與處理的個人資料，且 Milestone 及其授權人針對您根據任何適用法律收集、處理或使用個人資料的權利與義務不承擔任何責任或義務，包括但不限於 GDPR 與任何其他隱私與資料保護法。

Copenhagen Clause。 Milestone 為 Copenhagen Letter 簽署方之一員，其旨在公開誠實地交流科技之所及，與技術如何提升生活水準之方法。身為科技的塑造者，我們必須反映科技如何影響人的需求與行為，以及如何更負責任地善用科技。Milestone 鼓勵合作夥伴不只要積極參與關於如何以負責任方式利用科技的重要討論，還要簽署 <https://www.milestonesys.com/company-news/milestone/csr/the-copenhagen-letter/> 的 Copenhagen Letter，並在其協議中納入相對應之 Copenhagen Clause。

責任限制。 本部份介紹相關法律的最大適用範圍。在任何情況下，Milestone 或其供應商不對任何特殊性「偶發性」間接性或必然性損害（包括但不限於營業利潤損失「營業中斷」商業資訊遺失或其他任何財產損失所造成的損害）負責，也沒有任何產品責任（除非人身傷害），無論這些損害是否是由於使用本「產品」存在功能缺陷或無法提供適當支援所造成，即使 Milestone 經告知這些損害的可能性。如果損害並非由操作不當或嚴重疏忽所造成，則應由 Milestone 及其供應商承擔的任何責任將限制在您為此「產品」所支付的實際金額範圍之內。

第三方授權。 「產品」包含授予您使用特定第三方軟體之權利，詳情請參閱特定「產品」之說明書。您可以使用並將「產品」與其他第三方軟體進行整合，當您安裝時，應自行查明並取得任何該等第三方軟體之使用權。

Milestone 產品週期。 您對「產品」之使用情形，亦受到 Milestone 產品週期的規範，詳情請參閱 <https://www.milestonesys.com/support/tools-and-references/product-lifecycle/>。依據 Milestone 產品週期，授權啟用可在「產品」普遍推出後十年內使用。過了十年後，可能就無法再新增新 IP 裝置及/或對連接至「產品」以及在「產品」中啟用之 IP 裝置進行替換。不過，在符合 EULA 規定下，您將保有您使用「產品」的權利，而且既有的 XProtect 系統將持續運作。

其他規定。 (a) 您可以根據需要製作數量適當的「產品」複本，以作備份及歸檔之用，惟必須在該等複本上重製一切所有權聲明。(b) 除本 EULA 明確許可外，您不得將向第三方散佈、再授權或以其他方式提供「產品」。(c) 除適用法律允許並且在許可範圍內，您不得對「產品」元件的任何部分進行逆向工程、反編譯、修改、或反組譯，此限制不得透過契約放棄。(d) 本 EULA 不可轉讓，但如為轉移任何包括 Milestone 產品之所有權利益者，不在此限，在該情況下您可把您對「產品」之一切權利永久移轉給受讓人，惟該受讓人應同意本 EULA 的條款。

出口管制。 您在本 EULA 下的權利範圍與授權應受聯合國、美國、英國、丹麥和/或歐盟實施的任何適用制裁、出口管制法規或其他貿易限制措施所約束。如果該類使用遭到任何適用的制裁、出口管制條例或其他貿易限制措施禁止或受其約束，則您不得使用本「產品」或行使本協議項下授予的任何授權權利。如果根據適用的制裁或出口管制法律或法規而受到禁止時，Milestone 應無義務授權並提供任何 Milestone 產品。如果由於國家或國際對外貿易、海關要求、任何禁運或其他制裁而產生的任何限制和障礙，Milestone 沒有義務履行本 EULA。

終止。 在未損害其他任何權利的情況下，如果您未能遵守本 EULA 之條款與條件及/或您未能遵守或致使 Milestone 無法遵守適用之出口管制規定者，Milestone 得終止本 EULA，並且您不得據以主張損害賠償、退款或任何補償。在該情況下，您應立即停止使用「產品」，銷毀其所有複本，並出具書面銷毀證明。

可分割性。 若法院或政府執法體系判斷本 EULA 中的任何條款無效、不能強制執行或僅限於特定範圍強制執行，此現有 EULA 將於刪除或限制此條款的狀況下持續具有完整效力。

完整協議。 此 EULA 構成雙方在此議題上的完整協議，若雙方間除此 EULA 外尚有任何書面和口頭承諾、暗示保證、一般法律規則或未在此重新聲明的其他法律，現予排除其對雙方之效力。

準據法。 您與 Milestone 之間的本 EULA 和合約均以丹麥法律為準據法，而且哥本哈根市法院是對相關爭端進行裁決的唯一合法場所。

授權、安裝及使用條件及限制。 Milestone XProtect 視訊管理軟體產品支援 IP 裝置。IP 裝置可以是攝影機、編碼器、視訊服務或其他類型的視訊和非視訊裝置，這些裝置是在「產品」的應用安裝中透過唯一的 IP 位址定址。對於「Milestone 支援裝置清單」中包含的具有一個 IP 位址的 IP 裝置，每個連接並在產品中啟用的 IP 裝置都需要一個裝置授權。對於啟用了多個 IP 位址的 IP 裝置，所需的裝置授權數量明訂於「Milestone 支援裝置清單」中。請在 <https://www.milestonesys.com/support/software/supported-devices> 上的支援裝置清單中查看支援的 IP 裝置、所需的授權數量以及例外情況。以下例外情況適用於具有一個 IP 位址的 IP 裝置：(i) 對於透過中繼裝置或中間系統連接到產品的 IP 裝置，每個啟用的視訊頻道需要一個裝置授權；(ii) 具有多個鏡頭或感測器和編碼器的 IP 裝置，且最多可連接 16 個類比攝影機者，僅計為一個 IP 裝置；(iii) 對於具有 16 個以上頻道的編碼器，每個啟用的視訊頻道都需要一個裝置授權。其他特定例外情況可能適用，請參閱「Milestone 支援裝置清單」以瞭解詳細資料。

對於不在 Milestone 支援裝置清單內的 IP 裝置，以及包含在 Milestone MIP SDK 內的 Video Processing Service 驅動程式，適用以下規定：(i) 具有視訊功能的 IP 裝置，每個啟用的視訊頻道需要一個裝置授權；(ii) 沒有視訊功能的 IP 裝置，每個 IP 位址需要一個裝置授權。對於特定的 XProtect® 視訊管理軟體產品，可能適用特定的授權條款，請參閱產品的具體條款和條件，以及 (iii) 當 Video Processing Service 驅動程式從任何已連接的視訊處理系統或任何直接或間接連接的裝置接收視訊時，每個啟用的視訊頻道需要一個裝置授權。

系統資料蒐集與註冊。 啟用「產品」的授權，即表示您接受核心系統（例如使用的裝置數目）在 Milestone 的授權系統中進行交換與儲存。每個連接至系統之授權與裝置會產生唯一金鑰。Milestone 蒐集已連接裝置的 MAC 位址，並紀錄攝影機註冊與刪除的次數，以確保授權使用符合 EULA 規定。Milestone 亦會登錄啟用授權之伺服器 IP 位址。對於使用 Milestone 推播通知的系統，Milestone 會記錄下行動裝置伺服器的 GUID（全域唯一識別碼）、及註冊作為接收通知的行動裝置、及登錄作為接收推播通知的電子郵件地址。如果您對產品搭配使用任何外掛程式或其他整合應用程式，該等應用程式之相關基本資料也會在啟用產品授權時被蒐集並發送至 Milestone。整合應用程式相關資料包括以下資訊：製造商名稱、整合產品的名稱與版本。收集與維護系統資料的目的，是為了讓 Milestone 及其通路合作夥伴能夠加強 Milestone 產品的授權管理。對於整合應用程式，Milestone 將基於統計和分析目的，使用其所蒐集之資料。您同意不會變更、修改或以任何方式篡改傳輸至線上服務中的資料。

Milestone 特此授予您在下列條件與限制下安裝及使用本「產品」之權利：

1. 「產品」的「Management Server」元件可安裝於不限數量的依據「軟體授權碼」指定為管理伺服器以及可能的叢集管理容錯移轉伺服器的電腦。
2. 「產品」的「Recording Server」元件可安裝於不限數量的指定為錄影伺服器及容錯移轉錄影伺服器的電腦。錄影伺服器及容錯移轉錄影伺服器必須受到上述指定管理伺服器的管理。
